

HARVEST HOUSE

Male Residential Treatment Program

ADMISSION

- Referral paperwork including, Assessment, intake, medication list, and discharge information are completed and submitted to Residential Services Supervisor for consideration for acceptance.
- Each referral form is staffed with a clinical team which consists of counselors, licensed clinicians and registered nurses to ensure the individual is a fit for the program.
- Once the clinical team approves the referral, an admission date will be scheduled; if there is a delay that postpones admission, Harvest House will make every effort to work with applicant but no beds are held if other applicants awaiting placement meet criteria.
- Harvest House does not pick up applicants to transport for admission.
- When the client arrives to the facility they will start the process of medical and clinical clearance.
- Each resident will be drug tested upon arrival and it is expected that the client test negative for all substances and alcohol. If there is a positive test for any substances, final clinical clearance will be at the discretion of Clinical Director and Psychiatrist.
- After being medically and clinically cleared, new resident's belongings will be inventoried and any personal items will be stored away (cell phones, money, medications). ALL cloth based items will be sterilized by heat treatment unit before those items are stored in the assigned bedroom
- Residents will be allowed one 5-minute phone call on admission day; this will be negotiated with Residential Supervisor

WHAT TO BRING

- 7-day supply of clothes for public and bedtime that is appropriate for the weather
- Cigarettes for a minimum of 2 – 4 (for smokers)
- Long pants to be worn in AA/NA meetings and SACOT groups
- Comfortable closed-toe shoes for walking (no flip flops in AA/NA meetings/SACOT groups)
- Comfortable shoes for walking around the house such as slippers, flip flops, sandals, etc.
- 30-day supply of all prescription medications allowed at Harvest House in their original labeled pharmaceutical container
- 2-3 towels and 2-3 washcloths
- Personal hygiene products such as toothpaste, toothbrush, comb, brush, shaving razor, shaving cream, special shampoo, special soap, etc.
- Books
- Money for snacks

WHAT NOT TO BRING

Items below that are brought on campus will have to either be stored for you until your discharge or discarded by you, in order to remain in our residential program.

- Addictive prescription or non-prescription substances including, but not limited to:
 - Methadone, Suboxone, or other Buprenorphine-related product
 - Prescription or non-prescription narcotic pain relief products
 - Ultram or Tramadol

- Xanax, Alprazolam, Valium, Diazepam, Ativan, Lorazepam, Klonopin, Clonazepam, or other benzodiazepines
 - Ambien
 - Ritalin, Adderall, Concerta, or other prescription or non-prescription amphetamine
- Weapons of any kind including knives no matter how small
- No electronic devices including computers, games, laptops, cellular devices, tablets, etc.
- No magazines or pornographic material
- No mouthwash, cologne, hand sanitizer, or any other household or personal hygiene product containing alcohol or ethanol
- No shorts, sleeveless shirts, spandex, clothing that is too tight, pants that sag and show underwear, clothing with alcohol and/or drug-related writing or images, clothing that is likely to be offensive to others
